National Hydrologic Warning Council 2015 Membership Policy

(Approved 11/7/2014)

The NHWC has four primary categories of membership—Federal, Group, Individual, and Student. The NHWC bylaws provide that the term of membership is annual starting on January 1 and ending December 31. Membership benefits such as training, newsletters, emails, and conference/meeting discount rates, etc., apply to all levels.

<u>Federal Membership</u>—Federal agency memberships are for those agencies that have a genuine interest in hydrologic warning and want to have persons in their office involved in NHWC. Federal memberships are owned by the agency. Each Federal membership has one official vote for NHWC business by a person designated as the "primary contact" at the time of membership application/renewal.

<u>Group Membership</u>—Group memberships are for organizations that have an interest in hydrologic warning and wish to have multiple contact persons involved in NHWC. The fee structure that applies to all group memberships is in the table below. Definitions of what qualifies as a group member follows.

Group memberships are owned by the organization and are mailing address specific. This allows an organization to receive periodicals and have employees attend conferences and training seminars. It is strongly recommended that the person that arranges for conference attendance and/or advertising be listed as a contact to enable online processing of transactions.

Qualifications for Group Membership

Local/Regional Government - Counties, cities, flood control districts, river authorities, tribes, etc. that own or operate data collection systems that support hydrologic warnings; or use hydrologic data to protect lives, property and the environment; or have demonstrated a genuine interest in furthering the purposes of NHWC.

State Government – State agencies that own or operate data collection systems that support hydrologic warnings or use hydrologic data to protect lives, property and the environment; or have demonstrated a genuine interest in furthering the purposes of NHWC.

Corporation or Business Enterprise – Consultants, sole proprietors, product providers, private utilities, trade associations, non-profit organizations, universities, and others that own, operate, install or maintain data collection systems that support hydrologic warnings or use hydrologic data to protect lives, property and the environment; or have demonstrated a genuine interest in furthering the purposes of NHWC.

<u>Individual Membership</u>—Professionals and non-professionals joining individually rather than via their organizations.

All levels of membership receive one official vote for NHWC business by the person designated as the "primary contact" at the time of application submittal/renewal. All additional persons not listed as contacts from the organization will enjoy all other benefits of membership in NHWC. If your organization has a single person designated to arrange conference registrations and exhibits, etc. it is recommended that they be assigned one of the three contacts.

<u>Student Membership</u>—Student memberships are for those who are enrolled in full-time academic programs and have a genuine interest in hydrologic warning and want to be involved in the NHWC. Students will need to provide the name and contact information for an academic advisor or counselor who can confirm their academic status. Student members have the same benefits as Individual members.
